## Langley Debit Card Swipe into Savings Sweepstakes

You automatically receive one daily entry into the Sweepstakes drawing when you use your Langley VISA Debit Card attached to your checking account. Each day you use your Langley Debit Card you receive one entry into the monthly drawing!

## Official Rules

**NO PURCHASE, PAYMENT OR OBLIGATION NECESSARY TO ENTER OR WIN. **Sweepstakes Period:** Langley Debit Card Swipe into Savings Sweepstakes ("Sweepstakes") begins at 12:00:00 a.m. Eastern Time ("ET") on December 1, 2023 and ends at 11:59:59 p.m. ET on December 31, 2023 ("Sweepstakes Period").

**How to enter:** NO ACTUAL PURCHASE OR TRANSACTION IS REQUIRED to enter the Sweepstakes. Winner need not be present to win but must prove eligibility to receive prize. The odds of winning are dependent on the number of entries. There are two (2) ways to enter the Sweepstakes during the Sweepstakes Period. 1) Automatic Entry; and 2) U.S. Mail.

Automatic Entry: An eligible Langley VISA Debit Card cardholder with an open Langley checking account who uses his/her Langley VISA Consumer Debit Card ("Eligible Card") automatically receives one (1) Sweepstakes entry for the daily use of the debit card during the Sweepstakes Period.
